David Knall and Jeff Cohen are my brokers. I had every right to send this email to them.

I know your under incredible stress. I know your working your ass off to keep things on tract and most of all, I know SPG will survive and thrive when we get through this economic crisis.

I've told you many times how much I appreciate you and what you've done for SPG. Why do you think otherwise?

Its up to you to choose the truth in all of this. You may not like what I'm saying, but I don't lie.

I'm handling our life with whatever adjustments are necessary with budget meetings within my own office, not KSM, so delete that source, let's see, Art, the suck up, take no responsibility for his actions? I'd consider the source.
