Ms. McLaughlin:

Please be advised that the City of Indianapolis is continuing its efforts to make available for public inspection additional documents relating to the ongoing procurement process for the consolidated justice facility project ("CJUS Facility"). As you know, the City posted 847 pages of unredacted records to the Marion County CJUS Facility procurement web page (<http://www.indy.gov/eGov/ccjc/Pages/default.aspx>) on October 17, 2014. The October 17th release included the recently finalized: (1) Instructions to Offerors ("ITO"); (2) Public Private Agreement ("PPA"); and (3) numerous exhibits, forms, and appendices to each of the ITO and the PPA. To ensure the integrity of the City's ongoing negotiations with multiple industrial and commercial prospects for the construction and operation of the facility, certain information relating to the City's offer of public financial resources was temporarily withheld from just two (2) pages of a single exhibit (Exhibit E) to the ITO pursuant to IC 5-14-3-4(b)(5). Please note that the City anticipates being in a position to release the full contents of Exhibit E to the public during the week of November 24, 2014.

In addition to the already released ITO and PPA documents, the City is currently working in conjunction with key partners in the CJUS Facility project, including the anticipated end-users of the CJUS Facility (i.e., the Sheriff's office and Judges), to review and analyze several thousand pages of the Technical Provisions ("TPs") and Reference Information Documents ("RIDs") relevant to the project. Consistent with its obligation to ensure the safety of the public officials and members of the public who will use the CJUS Facility, the City is paying particularly close attention to identify any TPs and RIDs for which public disclosure would create a reasonable likelihood of threatening public safety by exposing a vulnerability to terrorist attack. *See* IC 5-14-3-4(b)(19). The City will begin releasing any TP and RID documents that are safe and suitable for public disclosure no later than the first week of December, 2014.

The City remains aware of your prior correspondence seeking "The request for proposals pertaining to the consolidated criminal justice complex." Although your request lacks the reasonable particularity required by the Access to Public Records Act (*see* IC 5-14-3-3(a)), the City remains committed to conducting a successful and transparent procurement and negotiation process and anticipates that the thousands of pages of records that have been (and will be) released are adequate to satisfy your request.
