Kite Realty Group Trust, 30 S. Meridian St., Suite 1100, Indianapolis, 46204 (www.kiterealty.com) a real estate investment trust, engages in the development, construction, acquisition, ownership and operation of shopping centers in the United States. It also provides real estate management and advisory services to third parties.

For the six months ended June 30, Kite lost \$2.9 million, or 2 cents per share, on revenue of \$83.5 million. That compares with a loss of \$8.8 million, or 10 cents per share, on revenue of \$61.0 million.

Kite Realty Group's shares trade on the New York Stock Exchange under the ticker symbol KRG. Information for Proxy Corner was taken from Yahoo Finance and from the company's proxy statement dated April 8, 2014.

The company in July acquired privately traded real estate investment trust Inland Diversified for \$1.2 billion and initiated a reverse split in its shares.
