MainSource Financial Group, 201 N. Broadway, Greensburg, Indiana, 47240, is the holding company for MainSource Bank, which has 91 offices in Indiana, Illinois, Kentucky and Ohio. In the first quarter, the company (www.mainsourcebank.com) earned \$8.8 million, or 40 cents per share. That compares with earnings of \$7.7 million, or 35 cents per share, in the same quarter a year earlier. MainSource shares trade on NASDAQ under the ticker MSFG.
